SCHOOL FEES POLICY

1. CURRENT FEES

Fees for the 2021/2022 academic year are £1800.00

2. FEES PAYMENT METHOD

All parents must pay the school fees by standing order you can set up the standing order with your bank by using the attached form. If you are registered with online banking you may choose to set up the standing order online yourself. Three available payment options are given below.

3. SCHOOL FEES FOR RECEPTION AGED CHILDREN

Reception aged children may be eligible for early years funding depending on their date of birth. Fees for Reception year will be calculated accordingly. Therefore, you may not have to pay fees or only part of the payment for the annum total. Please see the table below:

The full term payment will be applied for any mid-year admissions.

5. MID-YEAR LEAVING

The full term fees are applicable. **Fees are non refundable**, unless the pupil leaves within two weeks of joining, upon which an administration charge of £100 will be applied before refund is given.

6. OVER DUE FEES/LATE PAYMENTS

Children with outstanding fees from the previous term will not be able to attend school until the outstanding balance is paid.

Students with fees outstanding, unpaid full or in part will not be given their exam results, certificates or references to other schools and colleges until payment is recorded.

7. ANNUAL REVIEW OF SCHOOL FEES

School fees will be reviewed annually. The school reserves the right to increase fees as deemed necessary.

8. CONCESSIONS

7.1 Concession for school fees can **only** be obtained if requested by parents who have more than one child **and** are in receipt of the following benefits:

- Income Support
- Income-based Jobseeker's Allowance
- Support under Part VI of the immigration and Asylum Act 1999
- Child Tax Credit, provided they are not entitled to Working Tax Credit and having an annual income (as assessed by HM Revenue & Customs) that does not exceed £16,190
- Guaranteed element of State Pension

7.2 Concessions must be arranged and agreed with the Head Teacher and evidence of the above qualifying benefits must be supplied to the school before any concession can be made.

7.3 Only Parents with two or more children can apply for concessions. Concessions for school fees are applicable as stated below.
